

ICR Charity Classic Donation Request Considerations

At the ICR Charity Classic, we are committed to supporting local recipients who are dedicated to improving the lives of children and youth in our community. To ensure our donations align with this mission, we have established the following considerations for donation requests:

1. Eligibility Criteria

The ICR Charity Classic will consider donation requests that meet the following criteria:

Local Recipients: The organization or individual requesting the donation must be based in our local community.

Administration Costs: We prioritize organizations or initiatives where the funds requested will directly benefit the intended cause, with minimal allocated for administrative expenses. Requests with low administration costs or red tape will be prioritized.

Children and Youth Focus: The donation request should clearly demonstrate how the funds will be used to support children and youth in areas such as education, healthcare, social development, or other relevant services.

2. Types of Giving

We may provide charitable contributions in various forms, including but not limited to:

Direct Monetary Donations: Cash contributions to support the cause or project.

In-Kind Donations: Providing goods or services directly to the organization or initiative.

3. Application Process

To request a donation from the ICR Charity Classic, individuals or organizations should follow this process:

Submit a formal request that outlines the purpose of the donation, how it aligns with the focus on children and youth, and a detailed budget or plan for the use of the funds.

Provide documentation that confirms the organization's local status and demonstrates a commitment to not using the funds for administration costs.

All donation requests will be reviewed by the ICR Charity Classic's committee. The committee will assess each request based on the eligibility criteria and the alignment with our policy.

5. Donation Limits

We will establish donation limits for different types of giving, which will be reviewed and adjusted as needed to ensure responsible financial stewardship.

6. Non-Discrimination

The ICR Charity Classic does not discriminate on the basis of race, color, religion, gender, sexual orientation, gender identity, national origin, disability, or other protected characteristics in its charitable giving activities.

7. Reporting and Recognition

We will maintain records of all charitable contributions, including the recipient, amount, purpose, and date. The ICR Charity Classic may publicly acknowledge its charitable contributions, with a specific focus on highlighting the impact on children and youth in our community. The ICR Charity Classic along with any of associated recipients will acknowledge and abide by all privacy rights with any publicity in regards to underage / minors or unauthorized persons without prior consent.

9. Review and Updates

This policy will be reviewed periodically to ensure it remains relevant and effective. Any updates or changes will be communicated to our stakeholders.
